(iv) The registration is valid for a period of **6 years 6 months 28 days** commencing from **04-Mar-2020** and ending with **30-Sep-2026** unless renewed by the Real Estate Regulatory Authority in accordance with Section 6 read with rule 7.

(v) The Promoter shall comply with provisions of the Act and the rules and regulations made thereunder.

(vi) The Promoter shall not contravene the provisions of any other law for the time being in force in the area where the project is being developed.

(vii) If the above mentioned conditions are not fulfilled by the Promoter, The Real Estate Regulatory Authority may take necessary action against the Promoter including revoking the registration granted herein, as per the Act and the rules and regulations made thereunder.

(viii) This renewal shall have no affect on the timeline of handing over of possession of individual units to respective allottees, which has been mentioned in the individual agreement of sale (Section-13 of RERA Act, 2016, read along with Rule-9 of CGRERA Rules, 2017) executed between the promoter and allottee.
