(i) The Promoter shall execute and register a conveyance deed in favour of the Allottee or the association of the Allottees , as the case may be, of the apartment or the common areas as per section 17.

(ii) The Promoter shall deposit seventy percent of the amounts realized by the Promoter in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost to be used only for that purpose as per sub clause(D) of the clause (I) of sub section(2) of section 4.

(iii) The registration period has been extended by the Real Estate Regulatory Authority vide Order No. 25 dated 06 August 2026, read with Order No. 26 dated 11 August 2026, issued by the Authority, on account of Force Majeure.

(iv) The registration is valid for a period of **5 years 1 months 23 days** commencing from **25-Jul-2024** and ending with **16-Sep-2029** unless renewed by the Real Estate Regulatory Authority in accordance with Section 6 read with rule 7.

(v) The Promoter shall comply with provisions of the Act and the rules and regulations made thereunder.

(vi) The Promoter shall not contravene the provisions of any other law for the time being in force in the area where the project is being developed.

(vii) If the above mentioned conditions are not fulfilled by the Promoter, The Real Estate Regulatory Authority may take necessary action against the Promoter including revoking the registration granted herein, as per the Act and the rules and regulations made thereunder.

(viii) This renewal shall have no affect on the timeline of handing over of possession of individual units to respective allottees, which has been mentioned in the individual agreement of sale (Section-13 of RERA Act, 2016, read along with Rule-9 of CGRERA Rules, 2017) executed between the promoter and allottee.
