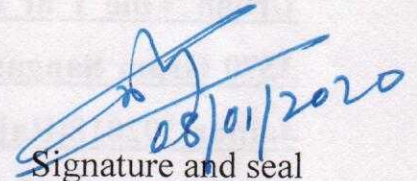
CERTIFICATE FOR EXTENSION OF REGISTRATION OF PROJECT

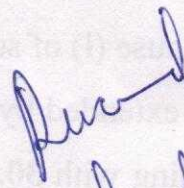
