the Real Estate (Regulation and Development) Act, 2016 read with rule 7 of the Rajasthan Real Estate (Regulation and Development) Rules, 2017;

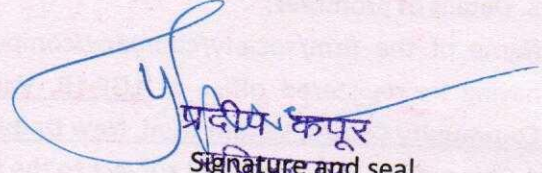
- (v) The promoter shall comply with the provisions of the Act and the rules and regulations made thereunder;
