The registration shall valid upto **08-10-2025**(Estimated Finish Date) unless extended by the Real Estate Regulatory Authority in accordance with section 6 of the Real Estate(Regulation and Development) Act,2016 read with rule 7 of the Rajasthan Real Estate(Regulation and Development) Rules,2017;
 - v. The promoter shall comply with the provisions of the Act and the rules and regulations made there under;



- vi. The promoter shall not contravene the provisions of any other law for the time being in force in the area where the project is being developed.
