 - iii. The promoter shall deposit seventy percent of the amounts realised by the promoter in a separate, account to be maintained in a scheduled bank to cover the cost of construction and the land cost to be used only for that purpose as per subclause(D) of clause(1) of sub - Section(2) of Section 4 of the Real Estate(Regulation and Development) Act, 2016



- iv. The registration shall valid upto **31-12-2028**(Estimated Finish Date) unless extended by the Real Estate Regulatory Authority in accordance with Section 6 of the Real Estate(Regulation and Development) Act,2016 read with rule 7 of the Rajasthan Real Estate(Regulation and Development) Rules,2017;
 - v. The promoter shall comply with the provisions of the Act and the rules and regulations made there under;
 - vi. The promoter shall not contravene the provisions of any other law for the time being in force in the area where the project is being developed.
